ADOPTION OF ANNUAL BUDGET: Let it be resolved, that the School Board of the Iroquois School District 2-3, after duly considering the proposed budget and its changes thereto, to be published in accordance with SDCL 13-11-2 hereby approves and adopts its proposed budget and changes thereto, to be its Annual Budget for the fiscal year July 1, 2019 through June 30, 2020. The adopted Annual Budget levy requests are as follows: TAX DOLLAR REQUEST – General Fund: Maximum, Opt Out Amount: \$100,000.00, Opt Out Amount: \$750,000.00; Special Education Fund: \$250,000.00; Capital Outlay Fund: \$500,000.00.

Motion by H Blue, second by Geyer to approve an executive session for personnel matters pursuant to SDCL 1-25-2(1) at 7:53 pm. All voted aye. Motion carried. Chairman Blue declared the meeting out of executive session at 8:40 pm.

Motion by H Blue, second by Schortzmann to approve Hunter Hayenga as a volunteer football coach. All voted aye. Motion carried.
